dog daycare & careless overnight boarding agreement and release

prior to boarding or attending our cageless daycare, dogs must complete our complimentary ½ day trial for temperament testing. the trial helps us to get to know your dog(s) and ensure that ruff life will be the most appropriate environment for him or her. we carefully screen all applicants. occasionally we determine that ruff life is not an appropriate environment for a particular dog. *please note: for health and safety reasons, ruff life reserves the right to permanently remove any dog from daycare and/or boarding at any time.*

please carefully read the information below and "the rules" (attached):

i understand and agree that in admitting my dog(s) to ruff life, ruff life has relied on my representation that my dog(s) is in good health and does not currently have, and has not had any communicable disease, illness or other health condition for at least one week prior to attending ruff life.

i understand and agree that my dog(s) is currently on, and will continue to be on, flea and tick prevention while at ruff life.

i understand and agree that my dog(s) have not shown aggressive or threatening behavior towards any person or other dog.

i understand and agree that in this cageless environment there are inherent risks. i voluntarily accept these risks, and release ruff life, ruff life employees, ruff life owners, ruff life independent contractors, and ruff life agents/assignees from any and all claims arising out of injury or damage in anyway related to or resulting from my association with ruff life.

i understand and agree that despite ruff life's efforts to maintain safety at the ruff life facility, there are certain risks involved in dog day daycare and cageless dog overnight boarding of dogs.

i understand and agree that i am solely responsible for any harm caused by my dog(s) while he/she is attending daycare and/or boarding at ruff life. i further release and discharge ruff life and ruff life employees, ruff life owners, ruff life independent contractors, and ruff life agents/assignees from any liability, claims and/or damages in connection therewith.

i understand and agree that in the event an emergency occurs while my dog(s) is in the care and custody of ruff life, and i am unreachable, ruff life and ruff life employees, ruff life owners, ruff life independent contractors, and ruff life assignees will seek immediate veterinary care for my dog.

i understand and agree that all costs in connection with above stated emergency veterinary care, including but not limited to transportation, veterinary/medical attention and all costs relating to, shall be my responsibility. as a result, below i am providing ruff life with my credit card information, to be used only for the above explained emergency purposes.

i agree that i have read and understand this "dog daycare and cageless overnight boarding agreement and release".

i agree to all terms, conditions, and statements of this " dog daycare and cageless overnight boarding agreement and release" and agree to abide by "the rules" (attached).

i agree that i am at least eighteen (18) years of age and that i have the authority to enter into this agreement with ruff life.

the rules

in order to maintain a safe environment for everyone, all ruff life guests must first:

- provide veterinary proof of current vaccinations for rabies, parvovirus, distemper and bordetella
- provide veterinary proof of spay/neuter by the age of 1 year
- be on a flea and tick prevention
- be in good health and has not had any communicable disease, illness or other health condition for at least one week prior to attending ruff life
- be well socialized with people and dogs

health:

at the time of admission, all dogs must be in good health and free from communicable disease, illness or other health condition, as this could jeopardize the health of your dog and the other dogs. if your dog is vomiting or has diarrhea, please do not bring him/her to ruff life until he/she is healthy. if your dog appears to be sick while at ruff life, we will separate your dog from the group and expect you to pick him/her up as soon as possible. if treatment is necessary, this will be at the owner's expense.

at the time of admission, all dogs must be on flea and tick prevention. if your dog has fleas or ticks, we will separate your dog from the group and expect you to pick him/her up as soon as possible. if treatment is necessary, this will be at the owner's expense.

For the safety and well being of puppies, please note that puppies must be at least 4 months old to attend ruff life. in addition, all puppies must be on a veterinary approved puppy vaccine plan.

medication and elderly care:

please clearly label all medications including: your pet's name, type of medication, dosage and schedule. if your dog is elderly or has special needs, please let us know and we will advise if we can accommodate.

reservation:

reservations are recommended, especially during holiday times. please remember to cancel any reservations within 48 hours, or a charge will be applied. a 50% deposit is required for all sleepovers and holiday time daycare.

drop off & pick up times (operating hours):

monday - friday: 7a.m. - 7p.m.

saturday: 10a.m - 5p.m.

sunday: 11a.m. - 4p.m.

please pick up during our operating hours. on special occasions, we can arrange for a specific pick up time not listed above, but this must be pre-arranged with a ruff life staff member and an extra charge will be applied.
